SJNG's Position: \$17,408 under-recovery.

ISSUE 2: What is the estimated purchased gas adjustment true-up amount for the period of January **2020** through December **2020**?

SJNG's Position: \$126,120 over-recovery.

<u>ISSUE 3</u>: What is the total purchased gas adjustment true-up amount to be refunded during the period of January 2021 through December 2021?

SJNG's Position: \$108,712 over-recovery.

ISSUE 4: What is the appropriate levelized purchased gas adjustment recovery (cap) factor for the period January 2021 through December 2021?

SJNG's Position: 55.10 cents per therm recovery (cap) factor
