Dear Mr. Baker:

Florida Public Service Commission (Commission) staff has reviewed the application for amendment of wastewater Certificate No. 517-S (application) submitted on behalf of Crooked Lake Park Sewerage Company (Crooked Lake or Utility) on July 2, 2020. After reviewing this information, we find the application to be deficient. The specific deficiencies are identified as:

- 1. **Proof of Noticing**. Rule 25-30.036(4)(b), Florida Administrative Code (F.A.C.), requires that the applicant provide proof of noticing pursuant to Rule 25-30.030, F.A.C. Rule 25-30.030(4), F.A.C., requires that the utility provide the Notice of Application to the Office of Commission Clerk, for Commission staff approval prior to distribution. Subparagraphs (a) through (h) of Rule 25-30.030(4), F.A.C., list the requirements for the content of the notice. Further, Rule 25-30.030(6), F.A.C., states that all applications requiring noticing shall be deemed deficient until affidavits of noticing required by Sections 367.045(1)(e) and (2)(f), Florida Statutes, along with a copy of the notice, are filed with the Office of Commission Clerk. Please provide a copy of Crooked Lake's draft notice of application. After staff has reviewed and approved the notice of application, and the notices have been distributed in accordance with Rule 25-30.030(5), F.A.C., please provide affidavits of noticing.
- 2. **Legal Description.** Rule 25-30.036(4)(e), F.A.C., requires that the applicant provide a legal description of the territory proposed to be deleted and a legal description of the remaining territory in the format prescribed in Rule 25-30.029, F.A.C. The legal descriptions provided by the Utility are not in the format prescribed in Rule 25-30.029, F.A.C. Please provide a legal description of the territory proposed to be deleted and a legal description of the remaining territory in the required format.

- 3. **Territory Map.** Rule 25-30.036(4)(g), F.A.C., requires that the applicant provide a map, showing township, range, and section with a scale such as 1" = 200' or 1" = 400', with the territory proposed to be deleted plotted thereon, consistent with the required legal description. The map provided by the Utility lacks complete range and township designations. Please update the map to specify whether the township indicated is North or South, and whether the range indicated is East or West. Also, please provide a full-sized hard copy of the territory map so that staff can verify that it is drawn to scale and is consistent with the legal description given in the format prescribed by Rule 25-30.029, F.A.C.
- 4. **Tariff.** Rule 25-30.036(4)(i), F.A.C., requires that the applicant provide all tariff pages that reflect the revised service area, which shall be consistent with Chapter 25-9, F.A.C. Please provide the tariff pages as required.

Your application will not be deemed filed until the deficiencies identified in this letter have been corrected. These corrections should be submitted no later than October 5, 2020, to the following address:
