Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida, LLC (DEF or Company) requests confidential classification of certain information filed in the Company's response to staff's first set of interrogatories (ROG) and staff's first request for production of documents (POD) in the above referenced docket. The Company is claiming confidentiality of information provided in response to ROGs Nos. 7 and 9, and POD No. 1 under Section 366.093(3)(d) and Section 366.093(3)(e), F.S.

Per the Statute, proprietary confidential business information includes, but is not limited to: Subsection (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and Subsection (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." The information provided in the ROGs and POD for which confidential treatment is being sought can be described as land lease information, including rental agreement, annual rental prices, and cost per acre.

Staff has reviewed the information DEF filed in the discovery responses. It is staff's opinion that the information that is the subject of this request meets the criteria for confidentiality contained in Section 366.093(3)(d), F.S. and Section 366.093(3)(e), F.S.
