Pursuant to Section 4.5.2 of AT&T Florida's Self Effectuating Enforcement Mechanisms Administration Plan ("SEEM Plan"), AT&T Florida hereby declares a force majeure event in connection Hurricane Sally that began on September 15 and continues to impact AT&T Florida's operations.

The Service Quality Measures ("SQMs") affected as a result of the force majeure event include all measures associated with Trunk Group Performance for all wire centers affected by Hurricane Sally that are listed on the attached spreadsheet. Additionally, the Provisioning, Maintenance and Repair measurements previously under force majeure per AT&T's March 23, 2020 filing due to Covid 19 will remain in effect, inclusive of the wire centers on the attached spreadsheet affected by Hurricane Sally.

AT&T Florida will apprise the Commission periodically on status, providing notification as this force majeure event concludes. Additionally, AT&T will continue to keep CLECs notified via our normal processes.
