Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida (DEF or Company) requests confidential classification for information contained in documents produced by DEF in preparation for the Office of Public Counsel's (OPC) June 25, 2020 deposition of DEF witness Terry Hobbs, specifically information appearing within amended Exhibit A of such documents. The material that is the subject of this request is found in Document No. 03792-2020, Bates Nos. Hobbs DEP DT 00001 through Hobbs DEP DT – 00050. This document is cross referenced to Document No. 03314-2020.

The Company is claiming confidentiality for certain information contained within the amended Exhibit A of materials produced by DEF in preparation of DEF witness Terry Hobbs deposition, under Section 366.093(3), F.S. Per the referenced Statute, propriety of confidential business information includes, but is not limited to: Subsections (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." The information provided in the aforementioned exhibit for which confidential treatment is being sought can be described as competitively sensitive information related to contractual business obligations included in the decommissioning contract between DEF, ADP CR3, LLC and ADP SF1, LLC. The Company asserts that the disclosure of this information would impair DEF's efforts to contract for goods or services on favorable terms.

Staff has reviewed the information within amended Exhibit A of materials produced by DEF in preparation for the deposition of DEF witness Terry Hobbs, as well as the Company's confidentiality request. In staff's opinion, the information that is the subject of the confidentiality request does meet the criteria for confidentiality contained in Section 366.093(3)(d) and (e), F.S. Therefore, staff recommends that the request for confidentiality of the afore-mentioned information included in Document No. 03792-2020, and cross referenced to Document No. 03314-2020, be approved
