I am writing in response to an article in my local paper, the Miami Herald, which reported that Florida Representative Lawrence McClure is asking your Commission to review the net metering rule for households with solar panels. It was also reported that Representative McClure wanted to "make sure constituents, ratepayers, aren't subsidizing millionaires'solar panels."

Three years ago, my wife and I made the decision to install solar panels on a home the same year we purchased it. It will take approximately 12 years for us to "break even" with the savings from our electricity bill. The main reason we installed solar panels was to decrease our part of the production of greenhouse gasses which is driving climate change. This has saved 7 metric tons of CO2 from entering the atmosphere each year. Our household makes less than 6 figures in salary/ year. We were able to afford solar panels because of a U.S. Tax Incentive Program (break), which was 30% of the total cost, and buying the panels through a co-op, which decreased the cost by 20% Meanwhile, Next Era Energy executives, of which FPL is a subsidiary, have annual salaries in the millions, according to the Palm beach Post. I do wish that anyone who could afford solar panels would do so. FPL charges consumers 12 cents/ kilowatt. We also pay \$10/ month even if we produce more electricity than we use. If we send excess energy into the electrical grid and produce more than we use in a year, FPL pays us 3 cents/kilowatt. Meanwhile, subsidies for coal and natural gas are in the billions in the US. What is not included in the energy costs of "dirty" and CO2 producing energy is the medical expenses from producing, and people inhaling, small coal related particles (PM25) and natural disaster costs from temperature increase, due to CO2 emissions with related natural disasters(hurricanes, floods, and fires). Miami is on track to have a heat index of over 105 degrees 1/3 of the year by 2030. Those of us who have solar panels are taking some of the load off the grid which could prevent rolling blackouts in the future if enough people installed solar panels. These are just a few reasons to keep the net metering rule in place or make it even more beneficial to households who chose to install solar panels. I would appreciate your kind consideration of my comments. I would be very willing to discuss the mater in detail further if you so desire and are interested.
