I had the opportunity to speak to Ellen Plendl of your staff and she was very helpful in expanding upon the very information you provided. Our conversation brought me to realize now that perhaps my initial comments may not have been stated as precisely as I wished. I am providing you with these revised comments, offered in my individual capacity as a Pembroke Pines City Commissioner, opposing natural gas rate hikes proposed.

I oppose granting any rate hikes to any natural gas utlity that refuses to pay to extend gas lines, at their own expense, into residential or commercial areas expressing an interest in buying gas.

I do not oppose connection fees, say one's own home to a gas line belonging to and installed by a gas utility at their own cost in front of said home. That is no different than how water is sold to residents by water utilities, or electricity, and other common utilities.

But the notion that built-out developments will finance the extraordinary cost of a gas utility's installation of capital infrastructure needed by them to deliver and sell natural gas into their own homes is unworkable. Whatever the reasons for this unusual construct, that approach is quintessentially unworkable, and this likely explains why so few homes in my city and many others can use clean natural gas.

I don't mind a rate increase if needed to help finance said installations. I don't mind the state finding financially workable ways to help utilities extend their services to wanting customers. I believe that over time the benefits of that

kind of effort or increase will offset the burden. But to raise rates on the few gas customers that exist now, while gas utlities do nothing to invest in the expansion of their own customer base, seems abusive to me and well, it's not much of a business model.

Therefore, I oppose any gas rate increase not tied to the expanding customer base via utility financed installation of gas pipe infrastructure, accessible by new customers, be they residential or commercial.
