DUKE ENERGY FLORIDA, LLC'S MOTION FOR TEMPORARY ABATEMENT OF THE THIRD SOBRA HEARING

Duke Energy Florida, LLC ("DEF"), pursuant to Rule 28-106.204, Florida Administrative Code, hereby files this Motion for the Florida Public Service Commission ("FPSC" or "Commission") to approve DEF's request to temporarily abate the hearing in this matter. Pursuant to the Order Establishing Procedure, Order No. PSC-2020-0230-PCO-EI, issued in this docket on July 10, 2020, an administrative hearing to consider DEF's Petition is scheduled on October 6, 2020.

DEF's Petition requests approval of five solar projects. The permit for one of those projects has not yet been issued, so the Company needs more time to obtain some additional clarity regarding the likelihood of approval of the permit.
