

- **3.** Referring to paragraph 12 of the petition, please explain the factors that led to the \$3,382,549 under-recovery (including interest) in 2019.
- A. The primary factor that led to the \$3,382,549 under-recovery is lower than projected sales of natural gas. \$10,398,531 of CI/BSR Revenue was collected during 2019, as shown on line 1 on page 2 of Exhibit A of the filing. This was \$1,086,047 lower than the estimated amount of \$11,484,578 of CI/BSR Revenue for 2019 shown on line 1, page 2 of Exhibit B in the 2020 Projection Filing. This reduced revenue was the main driver for the variance between the \$2,153,196 estimated under-recovery End of Period True-Up for 2019 shown on line 10 of page 2 of Exhibit B in the 2020 Projection Filing, and the End of Period Total True-up of \$3,382,549 shown on line 10 of page 2 of the 2021 Projection Filing.

At the time Peoples filed its original petition for the Cast Iron/Bare Steel Replacement Rider many of the customers in Rate Class SIS, Rate Class IS, and Rate Class ISLV were direct connect customers that did not use a large portion of Peoples distribution system and therefore were excluded from the Rider. Peoples believes that all customers benefit from the replacement of aging infrastructure to maintain a safe, reliable system and it is therefore fair and reasonable for customers in these rate classes to contribute a proportional cost of the program.
