RE: Force Majeure Declaration

Dear Mr. Teitzman:

Pursuant to Section 4.5.2 of its Self Effectuating Enforcement Mechanisms Administration Plan ("SEEM Plan"), AT&T Florida hereby declares a force majeure event in connection with Tropical Storm Eta that began on November 9, 2020 and continues to impact AT&T Florida's operations.

The Service Quality Measures ("SQMs") affected as a result of the force majeure event include all measures associated with Provisioning and Maintenance and Repair, as well as Trunk Group Performance in the attached wire center list. These wire centers began to see impacts on November 11, 2020 and are in addition to the 90 wire centers declared on November 9.

AT&T Florida remains under its statewide force majeure declaration related to the COVID-19 virus for Provisioning and Maintenance & Repair SQMs; the declaration for these measures began on March 20.

AT&T Florida will apprise the Commission periodically on status, providing notification as this force majeure event concludes. Additionally, AT&T will continue to keep CLECs notified via our normal processes.
