APPLICATION OF CHAPTER 7 TRUSTEE FOR ENTRY OF ORDER AUTHORIZING (1) EMPLOYMENT OF ACCOUNTANT, RETROACTIVELY, AND (2) THE TRUSTEE TO PAY ACCOUNTANT FIRST AND FINAL FEES

Gus A. Paloian, not individually or personally, but solely in his capacity as the Chapter 7 trustee (the "<u>Trustee</u>") of the bankruptcy estate (the "<u>Estate</u>") of the above-captioned Debtor (the "<u>Debtor</u>"), respectfully requests (the "<u>Application</u>") that this Court enter an order pursuant to 11 U.S.C. §§ 105(a), 327(a), 327(c) and 328(a), and Federal Rule ("<u>Rule</u>") of Bankruptcy Procedure 2014, (1) authorizing and approving the Trustee's retention and employment of the accounting firm of Kutchins, Robbins & Diamond, Ltd. ("<u>KRD</u>"), retroactively, to provide the Estate with accounting services on the terms stated herein, and (2) authorizing the Trustee to pay first and final fees to KRD in the amount of \$3,626.50. In support of this Application, the Trustee respectfully states as follows:

JURISDICTION AND VENUE

- 1. This Court has jurisdiction over this Application pursuant to 28 U.S.C. §§ 157 and 1334, and Internal Operating Procedure 15(a) of the United States District Court for the Northern District of Illinois.
- 2. Venue of the above-captioned case (the "<u>Case</u>") and of this Application is proper in this Judicial District pursuant to 28 U.S.C. §§ 1408 and 1409.

- 3. This matter is a core proceeding within the meaning of 28 U.S.C. §§ 157(b)(1) and (b)(2)(A) and (O).
- 4. The predicates for the relief requested herein are 11 U.S.C. §§ 105(a), 327(a) and (d), and 328(a), as supported by Federal Rules of Bankruptcy Procedure 2014.

I. PROCEDURAL HISTORY

- 5. On November 6, 2002, the Debtor filed its voluntary petition for relief under Chapter 11 of the Bankruptcy Code.
- 6. On December 13, 2005, the Court entered an Order converting the Case to one under Chapter 7. Also on December 13, 2005, the Court entered that certain Order directing the United States Trustee to appoint a Chapter 7 trustee of the Debtor's Estate. Subsequently, Gus A. Paloian was appointed to serve as Trustee.

II. RELIEF REQUESTED

- 7. Pursuant to Court Order entered May 8, 2006, the Trustee retained the accounting firm of Popoweer Katten, Ltd. ("Popoweer") to provide certain accounting services to the Estate, including, but not limited to, preparing and filing a tax return or returns for the Estate and preparing and filing employee payroll taxes. Popoweer performed these services through and including December 31, 2016.
- 8. As of January 1, 2017, Popoweer merged with KRD (the "Merger"). Due to the Merger, and subject to the Court's approval, the Trustee requests authority to retain the same accountants/tax preparers now employed with KRD to continue the effective administration of the Estate.
- 9. The Trustee believes that: (A) KRD is well-reputed and has extensive expertise in the field of accounting; and (B) that retaining and employing the same accountants/tax

preparers now employed with KRD would be the most efficient and cost-effective means by which to obtain tax accounting services.

- 10. KRD typically bills on an hourly basis pursuant to the rates listed on its hourly fee schedule (the "Hourly Rates"). The Hourly Rates can be found in the Fee Schedule which is attached hereto as **Exhibit 1**.
- 11. KRD has expressed its willingness to perform services for compensation pursuant to its Hourly Rates, and KRD will submit one or more fee applications in the future for this Court's consideration and approval.
- 12. The facts and circumstances supporting KRD's employment are set forth in the individual Affidavit of Lois West, a certified public accountant and principal of KRD (collectively, the "West Affidavit"). The West Affidavit is attached hereto as Exhibit 2.
 - 13. Pursuant to the West Affidavit, KRD represents that:
 - A. Neither KRD, nor any partner or employee thereof, holds or represents any interest adverse to the Debtor or the Estate;
 - B. KRD is a "disinterested person," as that term is used and defined in Sections 327(a) and 101(14) of the Bankruptcy Code, respectively; and
 - C. In accordance with Rule 2014(a), KRD does not have any connection with the Debtor, its creditors, the United States Trustee or any person employed in the office of the United States Trustee, any other party-in-interest, or its respective attorneys or accountants.
 - 14. KRD has not received any compensation from the Estate to date in the case.

15. The Trustee requests authority to pay KRD its first and final fees in the amount of \$3,626.50 without further order of the Court. A copy of KRD's itemized fee statement is attached hereto as **Exhibit 3**.

IV. BASIS FOR THE REQUESTED RELIEF

A. The Employment of KRD

- 16. Pursuant to Sections 105(a), 327(a), 327(c) and 328(a) of the Bankruptcy Code, and Rule 2014, the Trustee respectfully requests that the Court enter an order authorizing and approving the retention and employment of the accounting firm of KRD to perform tax accounting services on the terms stated herein.
- 17. Section 327(a) of the Bankruptcy Code authorizes the Trustee to employ, with the court's approval, one or more accountants "that do not hold or represent an interest adverse to the estate, and that are disinterested persons, to represent or assist the trustee in carrying out the trustee's duties under [the Bankruptcy Code]." 11 U.S.C. § 327(a). Furthermore, Section 327(c) provides that a "a person is not disqualified for employment under this section solely because of such person's employment by or representation of a creditor, unless there is an objection by another creditor or the United States trustee, in which case the court shall disapprove such employment if there is an actual conflict of interest." 11 U.S.C. § 327(c).
- 18. The facts and circumstances supporting KRD's employment are set forth in the individual Affidavit of Lois West, a certified public accountant and principal of KRD (collectively, the "West Affidavit"). The West Affidavit is attached hereto as Exhibit 2.
 - 19. To date, KRD has not received any compensation from the Estate.
 - 20. In addition, the West Affidavit represents the following:
 - a. KRD is a "disinterested person," as that term is used and defined in Sections 327(a) and 101(14) of the Bankruptcy Code, respectively; and

- b. In accordance with Rule 2014(a), KRD does not have any connection with the Debtor, its creditors, the United States Trustee or any person employed in the office of the United States Trustee, any other party-in-interest, or its respective attorneys or accountants.
- 21. In accordance with Bankruptcy Code Section 327(c), KRD is not disqualified for employment by the estate solely because of KRD's representation of Trustee Goldstein.

 Accordingly, KRD satisfies the applicable standards for employment by the estate pursuant to Bankruptcy Code Sections 327(a) and 327(c).

B. The Hourly Rates

- 22. Section 328(a) permits the Trustee, with the Court's approval, to "employ or authorize the employment of a professional person under section 327... on any reasonable terms and conditions of employment, including on a retainer, on an hourly basis, or on a contingent fee basis." 11 U.S.C. § 328(a).
- 23. An important policy consideration underlies this provision, that is, "[if] the most competent professionals are to be available for [employment in bankruptcy matters], they must know what they will receive for their expertise and commitment [and] [c]ourts must protect those agreements and expectations, once found to be acceptable." In re Merry-Go-Round Enters., Inc., 244 B.R. 327, 337 (Bankr. D. Md. 2000) (internal quotation marks omitted, alteration added, and quoting In re National Gypsum Co., 123 F.3d 861, 863 (5th Cir. 1997)).
- 24. Subject to this Court's approval, the Trustee is willing to pay KRD its Hourly Rates for its services, and requests this Court's approval to pay KRD's fees without further Order of the Court.
- 25. The Trustee believes that the Hourly Rates are very reasonable. In this respect, and based upon the Trustee's experience in hiring accountants in similar bankruptcy cases, the Trustee believes that the Hourly Rates: (A) appropriately reflect the nature of the services to be

provided by KRD; and (B) fall within, if not below, the compensation range that other accountants charge for similar services.

26. Accordingly, the Trustee respectfully submits that the proposed terms of KRD's employment should be approved pursuant to Section 328(a).

III. NOTICE

27. Notice of this Application has been given to: (a) the Office of the United States

Trustee, (b) the Debtor, (c) the creditors of the Estate, (d) those parties requesting notice in the

Case; and (e) to the extent not already included therein, those parties receiving notice via the

Court's CM/ECF system. The Trustee respectfully requests that notice be deemed sufficient and
that the Court find that no other or further notice is necessary.

IV. NO PRIOR REQUEST

28. No prior request for the relief requested herein has been made to this Court or to any other court.

WHEREFORE, Gus A. Paloian, not individually or personally, but solely in his capacity as the Trustee of the Debtor's Estate, respectfully requests that the Court enter an order: (a) granting the Application; (b) approving the Trustee's proposed employment of KRD, retroactive to the Merger; (c) authorizing the Trustee to pay KRD its first and final fees without further Order of the Court; and (d) granting any other relief the Court deems just and appropriate.
