We have reviewed the condition of the well house building located at the corner of Grassy Marsh Road and Lily Pad Road and recommend complete replacement of the building.

We visited the site on November 17, 2020 and observed:

- Cracking/Shifting/Misalignment of the block structure rows in the upper part of the structure.
- Cracking of existing block throughout the structure.
- Uneven/Settled foundation.
- Deterioration of roof members.

We do not believe, based on the deficiencies observed, that the structure is repairable and recommend replacement.
