2. I have personal knowledge of the matters stated in this Declaration.

3. I am an attorney, admitted to the practice of law and in good standing in the State of Illinois since 2006. I also am admitted to the practice of law and in good standing in the State of Texas since 2015. Since 2015, I have represented natural gas and electric utility clients in state regulatory proceedings before the Illinois Commerce Commission. I have also represented electric utilities in state regulatory proceedings before the Oklahoma Corporation Commission, the Missouri Public Service Commission, and the Kansas Corporation Commission. Additionally, I have represented electric utilities in numerous proceedings before the Federal Energy Regulatory Commission.
