2	CHAIRMAN CLARK: Next up is Item No. 5. We
3	are out of order just a little bit here. Number
4	MR. MOURING: Good morning, Commissioners.
5	This is Curt Mouring with Commission staff.
6	Item 5 is staff's recommendation to approve
7	East Marion Utilities' petition to defer legal
8	expenses associated with resolving a DEP issue.
9	Staff is prepared to answer any questions the
10	Commission may have.

23	next rate case. We will have an opportunity to
24	review whether those costs incurred are reasonable
25	and prudent. And if that is the case, I would like
