Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida, LLC (Duke or Company) requests confidential classification of certain information filed as part of the petition, in the above referenced docket, dated January 28, 2021. This recommendation addresses information contained in DEF's Minimum Filing Requirements, specifically portions of Schedule D-2.

The Company is claiming confidentiality of Schedule D-2 under Section 366.093(3)(e), F.S. Per the Statute, proprietary confidential business information includes, but is not limited to; Subsection (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." The information for which confidential treatment is being sought can be described as DEF's future affiliate capital structure, the disclosure of which may prevent parties from entering contracts with DEF, thereby harming its competitive interests.

Staff has reviewed the information DEF filed as well as the Company's confidentiality request. It is staff's opinion that the information that is the subject of this request meets the criteria for confidentiality contained in Section 366.093(3)(e), F.S.
