**REQUEST FOR CONFIDENTIAL CLASSIFICATION**

CSWR-Florida Utility Operating Company, LLC (“CSWR-Florida UOC” or “Applicant”), pursuant to section 367.156, Florida Statutes, and rules 25-22.006 and 119.071(5)(a)5., Florida Administrative Code, requests that the Commission classify as confidential social security numbers and other personally identifiable financial information contained in Exhibit O to CSWR-Florida UOC’s originally-filed Application. In support, CSWR-Florida UOC states:

1. CSWR-Florida UOC originally filed its Application on May 5, 2021. The Clerk assigned it document number DN 03907-2021.

2. Exhibit O as originally filed in document DN 03907-2021 contains social security numbers and other personally identifiable personal financial information on Exhibit O pages 1, 6-9, 26, 31-35, 55-59, 64, 75, 80-84, 89, 100, 105-109, 114, 126, 131-136, 174, 183, 184, 186, 186-190, 193, 198-202, 207, 214-217, 225, 230-234, 239 and 246-249.

3. On May 10, 2021, CSWR-Florida UOC filed a redacted version of the Application, with the referenced identifiers redacted. The Application was otherwise unchanged. The Clerk assigned it document number DN 03993-2021.

4. The redacted information is confidential and exempt from disclosure, including under rule 119.071(5)(a)5., F.A.C. Accordingly, CSWR-Florida UOC requests that the social security numbers and other personally identifiable personal financial information in DN 03907-2021 subsequently redacted in DN 03993-2021 be held as confidential and exempt from public disclosure.

WHEREFORE, CSWR-Florida UOC respectfully requests that the referenced information be classified as confidential and exempt from disclosure under the Public Records Act in Chapter 119, Florida Statutes, and Article I, Section 24(a) of the Florida Constitution. CSWR-Florida UOC further requests that the specified confidential information be classified by the Commission as confidential for the maximum period of time allowed and the unredacted copy of DN 03907-2021 be returned promptly to CSWR-Florida UOC upon closure of this docket.
