

CONSUMER COMMENTS

I am a 30 year customer of FPL and I disagree with the proposed FPL Rate Increase.

FPL Stock is traded through ticker symbol NEE (Next Era Energy) and has been

steadily increased 75% in the last 5 years. In the last 1 year, while the stock has NOT increased as much as previous 4 years, the stock is increasing in value vs. decreasing.

The Market Capitalization of NEE is close to \$150 Billion. While NEE has been

negatively affected by the COVID Pandemic, my bills have decreased very little.

While many other Floridians FPL costs have probably been decreased, the application

to have FPL Bill decreased due to economic hardship is NOT easy and NOT automatic.

FPL parent company NEE should have to show significant economic distress for many

quarter reporting periods to justify any increase in rates.
