FPL requests confidentiality of this information under Section 366.093(3)(d), F.S.: "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and Section 366.093(3)(e), F.S.: "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information."

Staff has reviewed FPL's confidential attachment to its response to Staff's Tenth Data Request, No. 7. Specifically, the attachment is a financial model of FPL's Residential Electric Vehicle Charging Services Pilot that can be used to derive vendor bid pricing; the disclosure of which would impair the competitive business and the efforts of the public utility to contract for goods or services on favorable terms. Therefore, staff recommends that this information meets the criteria for confidential classification pursuant to Sections 366.093(3)(d) and (e), F.S.
