Although FPL is required to obtain PSC authorization for billing rates for each calendar year based on projected costs of operation, mid-year corrections are allowed if its costs increase or decrease significantly during those years.

PSC rules require notification if fuel costs change by more than 10%.

Mid-year corrections work the opposite way, too. A year ago, as energy prices plunged at the beginning of the pandemic, FPL passed along its savings by discounting customers' May 2020 bills by 25%.
