#### ORDER APPROVING NAME CHANGE

#### BY THE COMMISSION:

On November 24, 2021, Utilities, Inc. of Florida (UIF or Utility) requested acknowledgement of a name change to Sunshine Water Services Company d/b/a/ Sunshine Water Services. UIF operates water and wastewater facilities in Charlotte, Highlands, Lake, Lee, Marion, Orange, Pasco, Pinellas, Polk, and Seminole Counties.

UIF consists of 27 systems, which were previously operated as individual utilities under the same owner until UIF's corporate reorganization and name change in 2016. As a result of the corporate reorganization and name change, UIF is the sole surviving corporation that owns and operates these water and wastewater systems. UIF is a wholly-owned subsidiary of Utilities, Inc. <sup>2</sup>

UIF's requested name change is consistent with Rule 25-30.039, Florida Administrative Code (F.A.C.), which provides for changes in name only, with no change in the ownership or control of the utility or its assets. The Utility provided a statement attesting that there will be no change in the ownership or control of the Utility and its assets. The Utility provided documentation from the Florida Department of State, Division of Corporations that the new name was registered in Florida effective January 1, 2022. The Utility provided a revised tariff reflecting the name change on January 18, 2022. On January 28, 2022, the Utility filed an affidavit stating that it mailed the approved customer notice to its customers.
