Dear Ms. Jackson:

This letter is in response to your letter dated March 22, 2022, in which you requested that we review and advise whether Subsection (7) of proposed Rule 25-18.020, Florida Administrative Code (F.A.C.), modifies the statutory language of Section 366.04(9)(b)3., Florida Statutes (F.S.).

Section 366.04(9)(b)3., F.S., states that monetary penalties imposed upon a communications services provider by the Public Service Commission (Commission) must be consistent with Section 366.095, F.S., Penalties. Section 366.095, F.S., states that the Commission has the power to impose a penalty upon entities subject to its jurisdiction that are found to have refused to comply with or to have willfully violated any lawful rule or order of the Commission or any provision of Chapter 366, F.S.

Because Section 366.04(9)(b)3., F.S., requires that the pertinent monetary penalties must be consistent with Section 366.095, F.S., we conclude that Subsection (7) of proposed Rule 25-18.020, F.A.C., does not modify the statutory language of Section 366.04(9)(b)3., F.S., by setting forth that only a "willful violation" or "refusal to comply" will result in the enumerated monetary penalties.

I have reviewed the above-referenced rule and offer the following comment for your consideration and response:

25-18.020(7):

Section 366.04(9)(b)3., F.S., requires the Commission to adopt a rule regarding monetary penalties to be imposed upon "any communications service provider that fails to comply with any such rule of the commission." Subsection (7) of this rule implements this provision; however, the rule sets forth that only a "willful violation" or "refusal to comply" will result in the enumerated monetary penalties. Please review and advise whether this distinction modifies the cited statutory language. See § 120.52(8)(c), Fla. Stat. (2021).
