Dear Members of the Public Service Commission,

I write today on behalf of the members of the Escambia Board of County Commissioners. Over the last several months we have been inundated with angry complaints from our constituents who have pleaded with us to help them get answers as to why their Florida Power and Light bills have increased so dramatically (in some cases more than doubling month over month).

Many have demanded that we contact you, the esteemed members of the Public Service Commission, to ask that you schedule a new public hearing to reconsider the decision you have made recently that allowed for Florida Power and Light to increase their rates in Escambia County leading to this situation.

Therefore, I am respectfully requesting, on behalf of my fellow commissioners and the citizens we serve, that you conduct a new public hearing to discuss this issue of FPL's rate increases specifically. We are also requesting that any such re-hearing be conducted in Escambia County, Florida (the largest population center in the Florida Panhandle) and noticed to us at least 30 days in advance so that we can inform the public so they may attend such a meeting. If a new formal hearing on these rates is impossible, then we are requesting that the members of the PSC hold a town hall meeting in Escambia County to hear from our constituents in a forum that allows their input to be heard by you directly.

Furthermore, we are requesting a detailed explanation to the following common questions/concerns we are hearing from our constituents:

 Why are our citizens being socially engineered to conserve-- by having their rates <u>increase</u> once usage exceeds 1000 Kilowatt hours per month? Why is this being allowed and condoned/encouraged by the PSC?

- Why are other energy sources/fuel commodities for electricity generation being excluded in favor of Natural Gas which has seen tremendous price increases—the costs of which are being burdened fully by ratepayers? Why is this being allowed and condoned by the PSC.
- 3. Why are our citizens apparently paying the highest rate per 1000 Kilowatt hours billed (residential) in the entire state of Florida? (See attachment 1.)
- 4. Why does the PSC consider these rates fair and reasonable given this current economic environment?
- 5. Why is FPL Northwest Florida cutting customers' power off early and not giving customers until 5:00 PM to pay bills that are late? (I have heard that customers' power is being shut off before 5:00 PM on the last day to pay a late bill, when previously if a customer paid before 5:00 PM the power would not be cut off.)

Of course, there are many more citizen questions that need to be answered so I trust you will thoughtfully consider and accede to our request to <u>schedule a hearing for the reconsideration</u> <u>of the FPL rate increases you approved----as soon as it is possible to do.</u>

This way, the Escambia County citizens we serve can be heard and can hear from you, in person, regarding this urgent matter.
