In Order No. PSC-00-0371-PAA-GU issued on February 21, 2000, in Docket No. 991758-GU, the Commission approved the territorial agreement entered into between Peoples Gas System, a division of Tampa Electric Company ("PGS"), and Clearwater Gas System, a department of the City of Clearwater ("CGS") (the "Agreement"). Section 5.1 of the Agreement calls for a meeting of the parties prior to the second anniversary of the effective date of the Agreement (and no more than every fifth anniversary thereafter), and a joint report on the status of the Agreement to be submitted to the Commission following such meetings.
