Dear Commissioner Passidomo,

My name is Jayne Kebe and I am a property owner at 18 Palm Drive on Knight Island. We have owned the property since 2012 and I have lived here as a full-time resident since 2016.

With this email, I am formally requesting that you follow the **PSC's staff recommendation to deny the Application of Original Certificate of Authorization by Environmental Utilities for a central sewer line for Don Pedro and Knight Islands.**

Briefly and to iterate, I have worked professionally as an environmental engineer for over 20 years and I can attest that EU does not have the experience and expertise for such an extensive sewer line installation and maintenance project.

More important to me personally, as an island resident, is the lack of any consideration or attention that has been given by EU to the effects of this project on the islands' gopher tortoise population and its habitats. According to the FWC, gopher tortoises are listed as Threatened, which is defined as a species likely to become endangered in the foreseeable future. Gopher tortoises share their burrows with more than 350 other species. Florida

law protects both the tortoise and its burrow. Per the FWC regulations, "Gopher tortoises must be relocated before any land clearing or development takes place" and permits must be obtained before capturing and relocating tortoises.

The Florida Fish and Wildlife Commission's Gopher Tortoise Program that is charged with restoring and maintaining secure, viable populations of gopher tortoises recommends enhancement of habitat quality and also requires that steps be taken to protect the GT and its burrow. No evaluation has been made by EU about the effects of the installation of these sewer lines on the gopher tortoise burrows or habitats. This is a terrible and inexcusable omission in my opinion.

Lastly, I would like to state my sincere appreciation of the work done by the PCS Commissioners and Staff for the detailed evaluation that they have made regarding this application. I know that significant amounts of research and documents have been submitted. A multitude of statements have been submitted to the PCS from the Don Pedro and Knight Islands residents with varying arguments supporting the denial of this application by EU. Thank you for reading and taking into consideration all of them.

My name is Joe Noto and I live at 181 N. Gulf Blvd., Placida, FL which is on Palm Island. I am one of the residents who will be impacted by your upcoming decision on whether to grant or deny the Environmental Utilities application to install a central sewer system on the island.

I respectfully request that you follow the PSC staff recommendation to deny this application for a number of reasons:

1. It will have a significant and unnecessary financial impact on me, a senior citizen.
2. As mentioned in one of my prior emails and supported by the PSC, there is no need for this central sewer system. To my knowledge none of the island property owners has requested a central sewer system and no state or local environmental regulator has mandated this service in our area.
3. I am still concerned about Environmental Utilities' financial and technical capability to handle a project of this magnitude.
4. And I've learned that despite having a central sewer system, the one they're proposing would still require me to periodically have a septic tank pumped. I am very diligent about maintaining my current septic system and participate in the island's batch pump-out program.

I appreciate the detailed attention the PSC staff and the Commissioners have given this matter. I also appreciate that you listened and gave consideration to our concerns and the impacts this proposal would have on me individually as well as our island community.

As president of the Beach Place Homeowners Association I am also speaking on behalf of our HOA which currently has 13 homes on 16 properties. We live on a beautiful island and work diligently to maintain our island environment.
