On July 28, 2022, Florida City Gas (FCG) filed a request for confidential classification pursuant to Section 366.093(3)(e) of the Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C), for information contained in FCG's response to the Federal Executive Agencies' (FEA) First Request for Production of Documents No. 2.

FCG claims the confidential information is intended to be and has been treated by FCG as private, its confidentiality has been maintained, and its disclosure would cause harm to FCG and its customers. Pursuant to Section 366.093, F.S., such materials are entitled to confidential treatment and are exempt from the disclosure provisions of the public records law. FCG also claims that the confidential information contains information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information. Specifically, the confidential information that is the subject of this request involves a financial report obtained through a paid subscription service. This information is protected by Sections 366.093(3)(e), F.S.

Staff reviewed the documents and information included in the discovery response and concurs with FCG that the information is available only to subscribers of the third party vendors' products and not available to the general public. In staff's opinion, the Company's request meets the criteria for confidentiality set forth in Section 366.093(3)(e), F.S. Therefore, staff recommends that FCG's request for confidential classification of the information contained in Document No. 05076-2022 be approved.
