SECTION 63.71 APPLICATION OF OPTICAL TELECOMMUNICATIONS, INC.

OPTICAL TELECOMMUNICATIONS, INC. (FRN: 0013932413) ("OpticalTel"), seeks authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. § 214(a), and Section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue certain voice services (the Affected Services) in Penney Farms, Florida because the contract providing for the physical space housing the wiring and equipment from which OpticalTel provides the Affected Services⁴ has been declared terminated and the physical space must be vacated.

OpticalTel provides the following information pursuant to Section 63.71 of the Commission's Rules:

1. Name and Address of the Carrier:

2. Date of Planned Service Discontinuance:

OpticalTel plans to discontinue the Affected Service on September 30, 2022, or as soon thereafter as any necessary regulatory approvals are obtained.

3. Points of Geographic Areas of Service Affected:

OpticalTel proposes to discontinue the Affected Services in Penney Farms, Florida.

4. Description of Services Affected: All interconnected VOIP telephone services,

including the following product offerings:

- <u>Digital Phone Basic</u>, an interconnected VOIP service that provides basic voice-grade telephonic communications with features, that can be used to place or receive one call at a time, and consisting of local exchange service and long distance service.

- <u>Digital Phone Plus</u>, an interconnected VOIP service that provides basic voice-grade telephonic communications with features, that can be used to place or receive one call at a time, and consisting of local exchange service and bundled nationwide long distance service.

OpticalTel will continue to provide the Affected Services in all other areas where they are currently provided.

5. Brief Description of the Dates and Methods of Notice to All Affected Customers:

OpticalTel has sent a written notification of the planned discontinuance to customers affected by the proposed discontinuance in accordance with Section 63.71(a) of the Commission's Rules. Customer notifications were sent by U.S. Mail on August 22, 2022. A copy of the notification is attached to this application (Attachment "A").

6. Whether the Carrier is Considered Dominant or Non-Dominant with Respect to the Service to be Discontinued:

OpticalTel is considered non-dominant with respect to the services to be discontinued.

7. Other Information

In accordance with Section 63.71(a) of the Commission's Rules, a copy of this application is being mailed concurrently with its filing to the entities listed on the attached certificate of service.

The public convenience and necessity will not be adversely affected by the discontinuance of the services described herein.
