15	The replacement of problematic plastic pipelines is		
16	expected to continue until 2028. The proposed		
17	surcharge would have a monthly bill impact of \$0.62		
18	for a residential customer uses 20 therms. Staff		
19	recommends approval of the proposed surcharges.
