THESE ESTIMATES ARE DERIVED FROM THE FOLLOWING PROCESS: FOR DISCONNECTION, THE SERVICE LINE HAS TO BE LOCATED AND DUG UP FOR THE LINE TO BE CUT AND CAPPED ON BOTH SIDES. SOMETIMES THIS MAY ALSO INVOLVE SHUTTING DOWN THE SYSTEM IN PART OR IN WHOLE. THE LINE THEN HAS TO BE BURIED. FOR RECONNECTION, THE PROCESS IS THE SAME: LINE HAS TO BE DUG BACK UP AND THE CAPS CUT OFF AND A NEW SECTION OF PIPE HAS TO BE INSTALLED TO RECONNECT BOTH ENDS. THE NEW SECTION OF PIPE HAS TO INCLUDE A CHECK VALVE AND ON/OFF CONTROL VALVE ALONG WITH A WATER VALVE BOX BEING INSTALLED. THIS MAY AGAIN INVOLVE SHUTTING DOWN THE SYSTEM IN PART OR IN WHOLE. THE LINE THEN HAS TO BE BURIED.
