Pursuant to Section 366.093 of the Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Florida Power & Light (FPL or Company) requests an extension of confidential classification of certain information filed in the above-referenced docket, dated May 11, 2021.
