- 1. <u>Big Bend Power Station (Pages 1 3 of Schedules B-7 and B-9)</u>
  It appears that there are no Adjustments or Transfers recorded in any account/subaccount associated with this power station on the plant side. However, there are Adjustments or Transfers recorded in various account/subaccounts associated with this power station on the reserve side with \$476,156,612 as the total. Please explain why there are only reserve adjustments and/or transfers but no corresponding plant adjustments or transfers recorded in the accounts/subaccounts associated with this station.
- A. There are only reserve adjustments due to the implementation of the Clean Energy Transmission Mechanism. The corresponding transaction on the Plant side is on the Retirement column. Refer to Order No. PSC-2018-0110-PAA-EI

2. Account 34199 Structures & Improvements - Solar (Page 7 of Schedules B-7 and B-9)

An Adjustments or Transfers balance, in the amount of \$42,391, was recorded on the reserve side in this account, but there is no corresponding balance of Adjustments or Transfers recorded on the plant side. Please explain why.

**A.** The adjustment of \$42,391 was made to correct the reserve balance for 34199 – Structures & Improvements - Solar.

There was \$42,391 transferred from Account 31140 – Structures & Improvements to account 34199 – Structures & Improvements - Solar.

An Adjustments or Transfer balance, in the amount of \$1,031, was recorded on the reserve side in this account, but there is no corresponding balance of Adjustments or Transfers recorded on the plant side. Please explain why.

- **A.** The adjustment of \$1,031 on the reserve side is due to the following adjustments:
  - There was \$1,074 positive adjustment due to the implementation of the Clean Energy Transmission Mechanism. Refer to order ORDER NO. PSC-2018-0110-PAA-EI.
  - There was \$43 transferred from Account 35200 Structures & Improvements to account 35000 Land to correct the reserve balance.

An Adjustments or Transfers balance, in the amount of \$8,383, was recorded on the reserve side of this account, but there is no corresponding balance of Adjustments or Transfers recorded on the plant side. Please explain why.

A. We have identified that the amount in reference does not match the amount in the ADSR. The adjustment in the ADSR of \$8,583 was made to correct the reserve balance for 35700 – Underground Conduit.

There was \$8,583 transferred from Account 35900 – Roads and Trails to account 357 Underground Conduit.

An Adjustments or Transfers balance, in the amount of \$9,082, was recorded on the reserve side in this account, but there is no corresponding balance of Adjustments or Transfers recorded on the plant side. Please explain why.

**A.** The adjustment of \$9,082 was made to correct the reserve balance for 35800 – Underground Conductors & Devices – Trans.

There was \$9,082 transferred from Account 35900 – Roads and Trails to account 35800 Underground Conductors & Devices – Trans.

An Adjustments or Transfers balance, in the amount of negative \$17,665, was recorded on the reserve side in this account, but there is no corresponding balance of Adjustments or Transfers recorded on the plant side. Please explain why.

**A.** The adjustment of negative \$17,665 was made to correct the reserve balance for 35900 – Roads & Trails - Trans.

There was \$9,082 transferred to account 35800 Underground Conductors & Devices – Trans. from 35900 – Roads and Trails – Trans.

There was \$8,583 transferred to account 35700 Underground Conduit – Trans. from 35900 – Roads and Trails – Trans.

7. Account 36500 Overhead Conductors & Devices – Distr (Page 8 of the Schedules)

Please explain why there is a negative Adjustments or Transfers balance, in the amount of \$81,752, recorded on the plant side of this account, but there is a positive Adjustments or Transfers balance, in the amount of \$1,151, recorded on the reserve side.

- **A.** The nature and cause for the adjustment is to correct the Distribution function Plant account usage.
  - There was \$300,106 transferred from Account 36800 Line Transformers to Account 36500 Overhead Conductors and Devices
     Distr.
  - There was \$5,765 transferred from Account 36600 Underground conduit to Account 36500 Overhead Conductors and Devices – Distr.
  - There was \$75,257 transferred to Account 36400 Poles, Towers & Fixtures from Account 36500 Overhead Conductors and Devices – Distr.
  - There was \$142,494 transferred to Account 36800 Line Transformers from Account 36500 Overhead Conductors and Devices – Distr.
  - There was \$4,693 transferred to Account 36900 Services OH from Account 36500 Overhead Conductors and Devices – Distr.
  - There was \$186 transferred to Account 36200 Station Equipment from Account 36500 Overhead Conductors and Devices Distr.
  - There was \$1,489 transferred to Account 356000 Overhead Conductors & Devices - Trans from Account 36500 Overhead Conductors and Devices - Distr

**8.** Account 37000 Meters-Analog & AMR- Distr (Page 8 of Schedules B-7 and B-9)

Please explain why there is a negative Adjustments or Transfers balance, in the amount of \$947,739, recorded on the plant side of this account, but there is a positive Adjustments or Transfers balance, in the amount of \$30,025,215, recorded on the reserve side.

A. The adjustment of negative \$947,739 was made to correct the plant balance for Account 37000 – Meters-Analog & AMR - Distr.

There was \$46,640 transferred to Account 36800 – Line Transformers OH UG from Account 37000 Meters-Analog & AMR.

There was \$901,099 transferred to Account 37001 – Meters - AMI from Account 37000 Meters-Analog & AMR.

We have identified that the \$30,025,215 amount in reference does not match the amount in the ADSR; the positive adjustment in the ADSR of \$36,025,215 on the reserve side is due to the following adjustments:

- There was a \$36,146,871 positive adjustment due to the implementation of the Clean Energy Transmission Mechanism. Refer to order ORDER NO. PSC-2018-0110-PAA-EI.
- There was \$121,656 transferred to Account 37001 Meters AMI from Account 37000 Meters-Analog & AMR.

9. Account 37302 LS2 Lighting (Page 8 of Schedules B-7 and B-9) TECO recorded the following in this account for the year ended December 2021:

i. Plant addition: \$874,960,ii. Depreciation Accrued: 22,955,iii. Gross COR: (\$5,111),iv. Gross Salvage: \$194.

It appears that this is the first time Account LS2 is presented in a depreciation-related schedule. Please identify the Commission Order with which the establishment of this account/subaccount is approved.

A. Tampa Electric established SubAccount 37302 for administrative purposes, to track assets related to the LS2 lighting rate. The company did not petition for Commission approval because we continued to use the depreciation rate in place for 373 assets.

**10.** Account 39000 Structures & Improvements – General (Page 8 of the Schedules)

Please explain why there is a negative Adjustments or Transfers balance, in the amount of \$109,436, recorded on the plant side of this account, but there is a positive Adjustments or Transfers balance, in the amount of \$6,562, recorded on the reserve side.

**A.** The adjustment of negative on the plant side of \$109,436 was made to correct the plant balance for 39000 – Structures & Improvements.

There was \$109,436 transferred to Account 39400 – Tool Shop & Garage Equipment from account 39000 – Structures & Improvements.

The positive adjustment in the ADSR of \$6,562 on the reserve side is due to the following adjustments:

- There was a negative \$6,423 transferred to Account 39400 Tool Shop & Garage Equipment from account 39000 – Structures & Improvements associated with the Plant transfer.
- There was a positive \$12,985 adjustment due to the implementation of the Clean Energy Transmission Mechanism. Refer to Order No. PSC-2018-0110-PAA-EI.

- 11. Total Depreciable Accounts (Page 8 of Schedules B-7 and B-9) Line No. 44 on page 8 of B-7 shows that the Adjustments or Transfers of TECO's total depreciable plant is zero. Line No. 44 on page 8 of B-9 shows that the Adjustments or Transfers of TECO's total depreciable plant reserve is \$527,170,052. Please explain why the total reserve Adjustments or Transfers do not net to zero.
- Α. While transfers within the 300 plant accounts would result in a net zero balance within this column, adjustments may occur outside of the 300 plant accounts. The total reserve Adjustments or transfers column do not net to zero due to an adjustment made to account 34199 - Str and Improvements-Solar from account 105.0 Land Property Held for Future Use.
