9	MR. WARD: Good morning, Commissioners.
10	Item 7 is a petition by Peninsula Pipeline
11	Company, Inc., for approval of a transportation
12	service agreement with Florida Public Utilities
13	Company.
14	The parties have entered into the proposed
15	firm transportation agreement to enable FPUC to
16	continue the natural gas customers in and around
17	the area of Lake Wales once Peninsula has acquired
18	the Citrosuco pipeline system.
19	Peninsula stated it has negotiated an
20	acquisition agreement with Citrosuco for the
21	Citrosuco pipeline system, and that the closing of
22	the pipeline agreement is contingent on Commission
23	approval of the proposed transportation agreement.
24	Furthermore, the parties asserted that
25	purchasing the existing pipeline, their negotiated

1	purchase price would be less costly than installing
2	a new separate pipeline to serve FPUC's customers.
3	The proposed transportation agreement
4	specifies an initial term of 20 years, and
5	thereafter shall be expended on a year-to-year
6	basis unless either party gives no less than 90
7	days of written notification of termination.
8	Staff has reviewed the agreement and
9	recommends approval.
10	CHAIRMAN FAY: Okay. Thank you, Mr. Ward.
11	Commissioners, you have a presentation on Item
12	No. 7. We will take a motion on that item at this
13	time.
14	COMMISSIONER CLARK: Move approval on Item 7,
15	Mr. Chairman.
16	COMMISSIONER GRAHAM: Second.
17	CHAIRMAN FAY: Okay. We have a motion and a
18	second to approve staff's recommendation on Item 7.
