

SECTION 63.71 APPLICATION OF LEVEL 3 TELECOM

Level 3 Telecom¹ hereby applies for authority under Section 214(a) of the

Communications Act of 1934, as amended, 47 U.S.C. § 214(a), and Section 63.71 of the

Commission's rules, 47 C.F.R. § 63.71, to discontinue a resold long distance service (the

Affected Service) in the areas listed in Appendix B (the Affected Service Areas), due to another

Lumen affiliate's discontinuance of the underlying long distance service.

Level 3 Telecom provides the following information pursuant to Section 63.71 of the

Commission's Rules:

2. Date of Planned Service Discontinuance

Level 3 Telecom plans to discontinue the Affected Service on June 29, 2023 in Walpole, Massachusetts; Florham Park, Palmyra and Summit, New Jersey; and Portland, Oregon, and on May 31, 2023 in the remaining areas listed in Appendix B, or as soon thereafter as any necessary regulatory approvals are obtained.

3. Points of Geographic Areas of Service Affected

Level 3 Telecom proposes to discontinue the Affected Service in certain portions of twenty-seven (27) states, as set forth in Appendix B.

4. Description of Services Affected

The Commission previously granted an application of Broadwing Communications, LLC (Broadwing) to discontinue various services, including certain long distance services.² One of those long distance services also is resold by Level 3 Telecom. In this Application, Level 3 Telecom seeks authority to discontinue this resold switchless long distance service in the areas listed in Appendix B. However, Level 3 Telecom's resale of the long distance services of other third-party carriers is not impacted by this Application.

5. Brief Description of the Dates and Methods of Notice to All Affected Customers

Level 3 Telecom sent a written notification of the planned discontinuance to customers affected by the proposed discontinuance in accordance with Section 63.71(a) of the Commission's Rules. Customer notifications were sent by U.S. Mail or United Parcel Service on April 3, 2023. A copy of the notifications is attached to this application (Attachment A).

6. Whether the Carrier is Considered Dominant or Non-dominant with Respect to the Service to be Discontinued

Level 3 Telecom is considered non-dominant with respect to the service to be discontinued.

7. Other Information

In accordance with Section 63.71(a) of the Commission's Rules, a copy of this application is being mailed concurrently with its filing to the entities listed on the attached certificate of service.

CONCLUSION

The public convenience and necessity will not be adversely affected by the discontinuance of the services described herein. Advance notice has been provided to all affected customers, giving them ample time to arrange substitute services, which are readily available from other providers. Therefore, Level 3 Telecom respectfully requests that the Commission approve this Section 63.71 application.
