1	requested rate increase is appropriate.
2	The company did not request interim rates, and
3	a hearing for this case is currently scheduled for
4	August 29th through September 1st.
5	CHAIRMAN FAY: Okay. Great. Thank you for a
6	summary on that item.
7	Commissioners, if there is any questions or
8	comments on the item. Showing none, I will take a
9	motion on Item No. 1.
10	COMMISSIONER GRAHAM: Move staff.
