PROCEDURES AFTER RECEIVING COMMENTS

Commission staff will prepare a recommendation on the utility's proposed rate increase which is tentatively scheduled to be submitted to the Commission on June 1, 2023. The Commission will then vote on staff's recommendation, taking into consideration customer comments, at its June 13, 2023, Commission Conference. As noted above, customers may address the Commission directly at this Conference. Customers may also watch the Commission Conference live from the PSC website at www.floridapsc.com. Look for the "Watch Live and Archived PSC Events" icon on the left side of the webpage.

The Commission will thereafter issue a proposed agency action (PAA) order containing rates which may be different from those contained in staff's final recommendation. Substantially affected persons have 21 days from the date that the PAA order is issued to protest the Commission's PAA order. Customers may obtain a copy of staff's recommendation and all documents filed in this docket under the Clerk's Office tab at the Commission's website (http://www.floridapsc.com).

CONTACTING THE OFFICE OF PUBLIC COUNSEL (OPC)

At any time during this process, you may contact the Office of Public Counsel.
