Today, Peoples Gas System, Inc. formally filed a petition with the Florida Public Service Commission (PSC) (Docket No. 20230023-GU) to begin the several months-long process of requesting and receiving approval for an increase to our customer base rates and service charges. If approved, we anticipate new rates will be effective in early January 2024.

The decision to raise rates is not an easy one for us. There is never a good time for it, and we know rising prices are affecting everyone. While we have managed our business prudently, Florida's population growth has been remarkable, and Peoples Gas must invest in new – and upgrade existing – infrastructure to serve this growth, as well as hire people to operate and maintain the expanding system. In the past 15 years, we have raised rates only once. The rates we are proposing for 2024 will help Peoples Gas continue to serve communities across Florida with safe, resilient natural gas and provide them with an award-winning customer experience.

### SYNOPSIS OF RATE REQUEST

THIS DOCUMENT IS PROVIDED BY PEOPLES GAS SYSTEM, INC. PURSUANT TO THE REQUIREMENTS OF RULE 25-22.0406, FLORIDA ADMINISTRATIVE CODE, NOTICE AND PUBLIC INFORMATION ON GENERAL RATE INCREASE REQUESTS

#### I. SUMMARY OF RATE CASE

On April 4, 2023, Peoples Gas System, Inc. ("Peoples" or the "company") petitioned the Florida Public Service Commission ("Commission") for an increase in its permanent base rates and charges.

The Commission, under Florida law, regulates rates, charges, and services provided by Florida investor-owned utilities. The Commission assigned Docket No. 20230023-GU to the case.

Peoples filed its test year letter on February 3, 2023, advising that, based on a review of the company's projected 2023 and 2024 financial performance, it must seek an increase in base rates to continue to meet the natural gas needs of existing and new customers, continue to provide safe, reliable, high-quality customer service, and have an opportunity to earn a fair rate of return on the company's investment.

Peoples' last rate case was filed in June 2020, with a final order issued in December 2020. In the two years since Peoples' last rate case, many factors have contributed to the necessity for the company to now seek rate relief, including: (1) growth in rate base; (2) increase in depreciation expense associated with rate base growth; (3) increasing costs associated with safely operating the company's system and complying with federal safety and security requirements; (4) high levels of inflation and resulting increases in the costs of labor, contractors, materials, insurance, and healthcare benefits; and (5) rising costs of long- and short-term borrowing and common equity.

Peoples has requested an increase of \$139.3 million in base revenues and charges, which includes \$11.6 million of 2024 revenue requirements related to moving \$93.3 million of net Cast Iron/Bare Steel Replacement Rider investments made through December 31, 2023, into rate base effective January 1, 2024. The result is a net revenue increase of \$127.7 million.

A more complete description of Peoples' request is provided in the petition and direct testimony of Peoples' witnesses and the detailed data supporting the request is contained in the Minimum Filing Requirement Schedules ("MFRs"), all of which were submitted to the Commission in the proceeding. An Executive Summary of the case is included in the A Schedules of the MFRs and in Exhibit A to this synopsis. A bill comparison showing typical monthly rates is contained in Exhibit B.

## II. COMPARISON OF THE PRESENT AND PROPOSED RATES FOR CUSTOMER RATE CLASSES

Based on current projections for fuel and other clauses, Peoples' typical residential bill (RS-2) under its proposed rates will increase by about 21 percent from 2023 to 2024.

Attached to this synopsis as Exhibit B are the current and proposed residential and commercial rates.

Under Peoples' proposal, customer classes would receive bill increases when the proposed new rates are put into effect on and after the first billing cycle period in January 2024.

#### **MAJOR RATE CASE ISSUES**

At the start of a general base rate case, it is not possible to anticipate all the issues that may arise, but potential major revenue requirement issues involved in the case could include:

- 1. Are the company's test year and sales forecasts reasonable?
- 2. What should be the value of the company's test year investment in rate base?
- 3. What should be the company's test year operating revenues?
- 4. What should be the company's test year operating expenses?
- 5. What should be the company's test year overall rate of return?
- 6. What should be the company's test year allowed rate of return on equity?
- 7. What will be the company's test year revenue deficiency?
- 8. What is the appropriate cost-of-service methodology to use in designing rates?
- 9. What will be the appropriate rate levels for each customer class of service?
- 10. What will be the appropriate charge for each miscellaneous service?

The specific issues in the case will be identified in a prehearing order issued prior to the hearing.

#### III. DESCRIPTION OF THE RATE CASE PROCESS

All public utilities, as defined in Section 366.02, Florida Statutes, must petition the Commission to increase their rates to retail customers. After the filing of the request, the Commission has eight months to conduct the case. The filing to request a base rate increase consists of the petition; direct testimony and exhibits from the company witnesses; and the MFRs, which are an extensive set of documents containing detailed data in support of the rate increase, including figures about a utility's costs, investment, and operations for the specified test year. The formal request is distributed to the Commissioners, the Public Service Commission staff, the Office of the Public Counsel ("Public Counsel"), and other parties who express interest in the case.

After the filing is made, the discovery process begins. During this process, the utility responds to requests for information (interrogatories) and requests to produce documents from the Commission staff and the parties (intervenors) to the case. The Commission staff performs a field audit of the company's filed data to ensure compliance with Commission rules and the accuracy of the information provided. Formal depositions (interviews) with company witnesses may also be conducted to gather information and better identify issues.

Intervenors in the case often present their own witnesses, testimony, and exhibits in response to the company's filing. They use the company's initial filing materials, as well as discovery responses from the company, as a basis for the positions they take in the case. The parties, their witnesses, testimony, and exhibits are subject to discovery as well. The company will then have the opportunity to present rebuttal testimony and exhibits to any intervenors who file testimony.

Toward the end of the discovery process and just before the hearing commences, the company, staff, and intervenors prepare issue lists and preliminary positions for the case. These lists of issues are then combined and narrowed in a Prehearing Order in an effort to help the Commission focus on the important facets of the case during the hearing.

The first hearings in a rate case – called "service hearings" – generally commence a few months after filing and are scheduled by the Commission. Some service hearings will be held in person, while others will be held virtually and conducted via the Go-To-Meeting platform. Details on how to participate by audio-only are provided on the Commission's website (<a href="www.floridapsc.com">www.floridapsc.com</a>), under "Hot Topics." These hearings will enable customers to express their views regarding the company's rate request. The Commission takes these views into account when ruling on the case.

The Commission has scheduled service hearings for the following dates:

Public Counsel has intervened in this docket and will be present at the service hearings to represent the public. Public Counsel may be contacted prior to the hearing at 111 West Madison Street, Suite 812, Claude Pepper Building, Tallahassee, Florida 32399-1400, or by phone at (800) 342-0222.

The next hearing in a rate case is a technical hearing. At this hearing, the legal "record" is further established for deciding the case through direct, rebuttal, and cross-examination testimony and the introduction of exhibits and other relevant evidence. The technical hearing in this case will be held on August 29, 2023, through September 1, 2023, at the Betty Easley Conference Center, Room 148, located at 4075 Esplanade Way in Tallahassee, Florida.

After the technical hearing, legal briefs are filed by the parties to summarize their positions. The Commission staff reviews the briefs and the record produced at the hearing and then produces a recommendation to the Commission that addresses each issue identified in the case.

The Commission then holds a Special Agenda Conference and votes on the revenue requirements and then a subsequent hearing will be held at a later date on the rate issues. After the votes, Commission attorneys prepare a final order that reflects the Commission's votes and provides background for the case, the basis for each of the decisions reached, the new approved rates, and the effective dates of the new rates. After the Commission order is issued, parties will have an opportunity to ask the Commission to reconsider its decision on the issues.

# Why Bret shouldn't impact the United States

Fortunately, Bret is not a threat to the continental U.S.

As of mid-day Tuesday, Bret is generating plenty of convection, but the strongest storms are not co-located with the low-level center of circulation, with the low-level center of circulation, preventing much strengthening thus far. Wind shear will increase as Bret moves into a drier environment; a little more intensification is possible through early Thursday, but Bret should plateau and then weaken thereafter.

and then weaken thereafter.
The NHC is no longer calling for Bret
to reach hurricane intensity prior to the
islands, and the storm is most likely to
dissipate over the weekend in the Central or Eastern Caribbean thanks to unfavorable upper-level winds caused by a trough over the eastern U.S. Remnants of Bret will likely continue west into Central America early next week.

#### What's behind Bret? Tracking the next tropical wave which will likely become Cindy

But wait, there's more! To Bret's east is yet another well-or-

ganized tropical wave, blithely spinning away as if this was early September. Storm activity is a bit anemic with this disturbance today, but slow develop-ment into a tropical depression or trop-ical storm is likely by Friday as the wave moves west-northwest through a favor-able environment.

While the eventual development of Tropical Storm Cindy is probable, this system will turn north over the weekend towards a break in the Bermuda high and should move out to sea early next week without affecting land areas.

While the combined impacts of Bret While the combined impacts of Bret and potential Cindy are expected to be minimal to modest, their very existence is an affront to hurricane climatology, Historical early-season tropical devel-opment is clustered in the western Caribbean and Gulf of Mexico, with only three cases since 1900 of a storm form-ing east of the Lesser Antilles in June— the Trinidad hurricane of 1933, Ana in 1979, and the 2017 iteration of Bret. Twin tropical cyclones in the eastern Atlantic in June are, well, unprecedented. Sorry.

# Bret and Cindy may foretell a more active season

And this may not be meaningless dis-

Years in which the Main Develop-ment Region (MDR), stretching from Central America to West Africa, is active prior to mid-July tend to remain busier than normal in the MDR for the rest of the hurricane season. While the rela-tionship is not foolproof, the extreme warmth of the Tropical Atlantic is more likely than not to persist into August and September and give tropical waves a better chance of development in the peak season.

Still, MDR warmth is just one piece of the puzzle, and the same pattern help-ing create Bret and company is keeping them away from the continental U.S. The last week has been dominated by a The last week has been dominated by a strong subtropical jet stream racing from west to east across the Southeast U.S. and into the Atlantic, which has caused the ridge of high pressure ("Bermuda high") usually over the subtropical stricts of the subtropical stric cal Atlantic in the summer months to be quite weak.

Weaker tropical trade winds associ-ated with this feeble high have allowed the MDR to warm to near-peak season levels, while also keeping shear lower than usual. However, the southerly pothan usual. However, the southerly po-sition of the jet is also causing the winds aloft over the Caribbean and western Atlantic that should neutralize Bret and keep a potential second storm away from land.

#### How weird tropical steering currents fed a barrage of North Florida severe weather

Closer to home, this bizarre, almost spring-like jet stream pattern dominat-ed by deep cut-off lows over the eastern U.S. is causing significant weather agi-tation in Florida and much of the Deep

While daily afternoon thunderstorm activity is typical in June, it's not typical for Florida to be clocked by organized complexes of severe thunderstorms every 14 hours for 10 days.

The culprit is a rare overlap between

both convective potential energy (a.k.a. CAPE, driven by solar heating and common in the summer) and strong wind mon in the summer; and strong wind shear (driven by jets, uncommon over Florida in summer). Shear and CAPE are kind of like the Stevie Nicks and Lindsey Buckingham of thunderstorms; individ-ually, they can produce impressive work, but when they come together, the

work, but when they come orgener, the results can be truly explosive.

In this case, a sheared environment has caused thunderstorms to be able to sustain themselves over much longer timeframes than usual, triggering damaging winds and the localized rain totals of 12 inches or more seen in Pensacola. Look for this wet and stormy pattern to wind down for Florida heading into the weekend as the cutoff low finally moves


weekend as the cutoff flow innary innecs away, the jet stream retreats north, and the atmospheric Mac attack breaks up. Overall, it's too early for these kinds of storms and way too early for me to be tapping into Key Lime Lacroix stock-piles to write Main Development Region storm forecasts, vet here we are. The storm forecasts, yet here we are. The good news is that Bret is not a U.S. threat, but the bad news is that, to the chagrin of meteorologists, we remain well off the beat path of weather history. What can be done but to keep watching the skies?

# 6 teenagers shot after Milwaukee celebration

MILWAUKEE - At least six teenagers MILWAUKEE – At least six teenagers were shot around where Milwaukee's Juneteenth celebration had just wrapped up, according to police and fire officials.

The shooting happened about 4:20 p.m. Monday outside Greater Philadelphia Church of God in Christ, according

phia church of God in Christ, according to witnesses and a Facebook Live video taken by a bystander in the immediate aftermath of the shooting, according to local media outlets. Milwaukce Police Chief Jeffrey Nor-

minwauker Police Unter Jerriey Nor-man said six teens were shot, including a17-year-old who may have been a gun-man himself and is in custody. Police were still seeking additional suspects who hadn't yet been identified. Police said the victims ranged in age

from 14 to 19.

Police said the victims ranged in age from 14 to 19.

Norman said the shooting may have stemmed from a fight among a number of girls and young women, but he didn't know what sparked the dispute. The injuries of those wounded varied but did not appear life-threatening, the chief said.

"Milwaukee, what's going on with our children?" Norman wondered aloud at a news conference. He noted that he has taken part in the city's Juneteenth extended the staken part in the city's Juneteenth any such bloody aftermath.

"Parents, guardians, elders, we need to engage in ensuring that this violence that our children are bringing these streets ceases. No handgun, no weapons of destruction, should be in the hands of our young ones."

"This is a story that plays out too often, and it's getting really old. Really old," Norman said.

of the shooting, he said.




