PEOPLES GAS SYSTEM INC.'S NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

Peoples Gas System, Inc. ("Peoples" or "the company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006(3)(a), Florida Administrative Code, hereby files this Notice of Intent to Request Confidential Classification for portions of the deposition transcripts identified in Exhibit A ("Confidential Material").

REQUEST

- 1. The company anticipates the discussion of, viewing of, and production of confidential material at the depositions identified in Exhibit A.
- 2. The company filed eighteen requests for confidential classification ("Requests")¹ in this proceeding seeking to protect materials containing proprietary confidential business information provided in discovery responses, deposition transcripts and testimony. Some of this confidential information, subject to pending Requests, may be disclosed or discussed at the depositions identified in Exhibit A, making portions of the transcript thereof confidential.
 - 3. Rule 25-22.006(1)(d), Florida Administrative Code, defines "material" to mean:

all documents, papers, letters, maps, books, tapes, books, tapes, photographs, films, sound recordings, or other recorded information regardless of physical form or characteristics.

4. The term "obtaining material" means:

receiving material pursuant to filing or taking physical control of material by removing the original material or a copy of it from the utility's or other person's premises. Obtaining material also means the extraction of data from material for inclusion in working papers or memoranda.

Rule 25-22.006(1)(e), Florida Administrative Code

5. Upon receipt of the confidential transcripts of the depositions identified in Exhibit A, the Commission will "obtain[] material" that constitutes confidential information under Rule 25-22.006, Florida Administrative Code. Accordingly, the company will file its Request for Confidential Classification specifying the portions of the deposition transcripts that Peoples asserts are entitled to confidential treatment within twenty-one days of the Commission obtaining the material – the copies of the deposition transcripts - in accordance with the Rule 25-22.006(3)(a)1., Florida Administrative Code.
