On December 19, 2023, pursuant to Section 366.093, F.S, and Rule 25-22.006, F.A.C., Duke Energy Florida (DEF or Company) requested a second extension of confidential classification for information filed in the highlighted portion of the transcript for the deposition of Richard A. Polich, P.E. taken June 12, 2020, in the above-referenced docket. The material that is the subject of this confidentiality request appears in Document No. 03477-2020 and is cross referenced to Document No. 03150-2020.

On July 1, 2020, DEF filed the original Request for Confidential Classification related to this document. DEF's Request was granted by Order No. PSC-2020-0358-CFO-EI on October 9, 2020. Subsequently, on April 4, 2022, DEF filed its First Request for Extension of Confidential Classification for this document. That request was granted by Order No. PSC-2022-0231-CFO-EI on June 27, 2022.

The Company is claiming confidentiality of portions of the transcript for the deposition of Richard A. Polich, P.E. under Section 366.093(3), F.S. Per the Statute, propriety of confidential business information includes, but is not limited to: Subsections (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." The highlighted information provided in the aforementioned transcript for which confidential treatment is being sought can be described as information revealing vendor-specific information related to DEF's request for information and request for proposal process.

Staff has reviewed the information provided in the transcript for the deposition of Richard A. Polich, P.E. as well as the Company's confidentiality request. In staff's opinion, the information that is the subject of the confidentiality request does meet the criteria for confidentiality contained in Section 366.093(3)(d) and (e), F.S. Therefore, staff recommends that the request for extension of confidentiality of the highlighted portions of information included in Document Nos. 03477-2020 and 03150-2020 be approved.
