Dear Wedgefield Customer,

Pluris Wedgefield, LLC is providing an update to you with information regarding the Pluris Wedgefield, LLC rate case to be filed with the Florida Public Services Commission ("PSC") in September, and information on a Board of County Commissioners' meeting scheduled for <u>September 12th</u>.

The accompanying PDF is part of a comprehensive filing to the PSC and provides requested rates as part of the PSC rate case application. Please note that although Pluris may not get 100% of the increase requested, Pluris will get a substantial increase in light of the fact that Pluris has not filed a general rate case in over 10 years.

In accordance with PSC rules, Pluris may begin charging interim rates 60 days after filing the rate case application, and the final rates implemented at the end of the rate case.

The following percentages reflect increases above the current respective water and wastewater rates.

Water	<u>Wastewater</u> Interim – 42%		
Interim – 44%			
Final - 46%	Final - 108%		

As you may be aware, Pluris has been in discussions with Orange County for the past three years regarding a potential acquisition by the County. The Board of County Commissioners are holding a Board meeting on **September 12**th to discuss the potential acquisition. Although Pluris will be filing its rate case application in September in accordance with the PSC schedule, Pluris will consider holding off implementing the interim rates should the Board of County Commissioners decide to move forward with the acquisition.

Customers are encouraged to attend the Board of County Commissioners meeting on <u>September 12th</u>. Customers can provide comment during the Public Comment period beginning at <u>9:00 AM</u>. The meeting will be held at the following location:

I shut the water off at the house; wrote down the number on the meter came back several hours later the meter number was still the same BUT when I looked at the AquaHawk program I found random 1 gal usages (by hovering over the times) and an 8 gal and 2 gal usage.

Surprised, I had to check longer so I did it over a 3 day period and found an additional 25 gallons that I DID NOT use. Remember there was zero usage reading on the meter when I shut the water off at the house so I know for a fact the line between the house and meter is not leaking. I can only imagine what is happening during a monthly cycle. These gallons ALL add up. NOTE: I did this just to see if I had a leak and discovered Pluris system adding usage randomly that I did not use. I DO NOT have a purification system of any on my property nor do I use Pluris for irrigation as I draw water from the lake I live on. Also, my neighbor IS NOT STEALING my water as 1. This was performed while water to my house was shut off. and 2. My property is monitored by cameras and no one tampered with my system at ANY given time.

My water was shut off between 730am-300pm 10 gallons how? Meter number stayed the same.

My water was shut off between 730am- 300pm 1 gallon shows. meter number stayed the same

I would like it to be known I tracked our water usage for a week through Aquahawk and by turning off the main water valve to our house and writing down the meter number to see if the meter moved to be sure I did not have a leak. My findings were NO LEAKS but discovered charges for water usage at the time my water valve was shut off. Once I gathered all my evidence, I filed a complaint with Florida Public Service Commission AND Florida Department of Agriculture and Consumer Services. Pluris was then notified of my complaint. I was contacted by Mr. Kuck of Pluris and was first told I must have a leak and then our water usage on Aquahawk and with Pluris is based on an estimate usage. I requested Mr. Kuck of Pluris to send me their in-house usage tracking report and found that the same usage when my water was OFF, appeared on his report. I informed Mr. Kuck of my findings and his response sarcastically "What do you want me to do?" I said, "At this point I would accept under \$100 monthly bills as this current amount is killing us". He laughed and I said, "I didn't find humor in this". Surprisingly, the next 6 months after my complaint was filed my bill dropped around \$100. But here we are again after Decembers 2023 rate increase my bill is once again up and another increase in the works. We need a resolution!


To Pluris,
