I am writing to you today as a concerned property and business owner in Charlotte County, to express my strong support for the implementa of a centralized sewer system. The urgency of this issue cannot be overstated, as the current reliance on septic systems is having a detrimental effect on our local environment and, by extension, our community and economy.

As an owner of several properties and businesses in the area, I have witnessed firsthand the negative impacts of inadequate waste management. For instance, while fishing in Little Gasparilla Pass

recently, I encountered human feces in the water. This is a direct result of septic runoff, an issue that not only affects the natural beauty and safety of our waters but also the health of our community and wildlife.

Moreover, one of our properties on Little Gasparilla Island faces significant accessibility challenges due to septic runoff, which becomes particularly problematic at high tide or after heavy rains. These are critical factors that support the overall vitality and attractiveness of Charlotte County as a place to live, work, and visit. I urge you to consider the overwhelming evidence supporting the need for a centralized sewer system and to take decisive action that prioritizes the health of our environment and community.
