The water and wastewater systems are operated under a contract with a professional operating company.

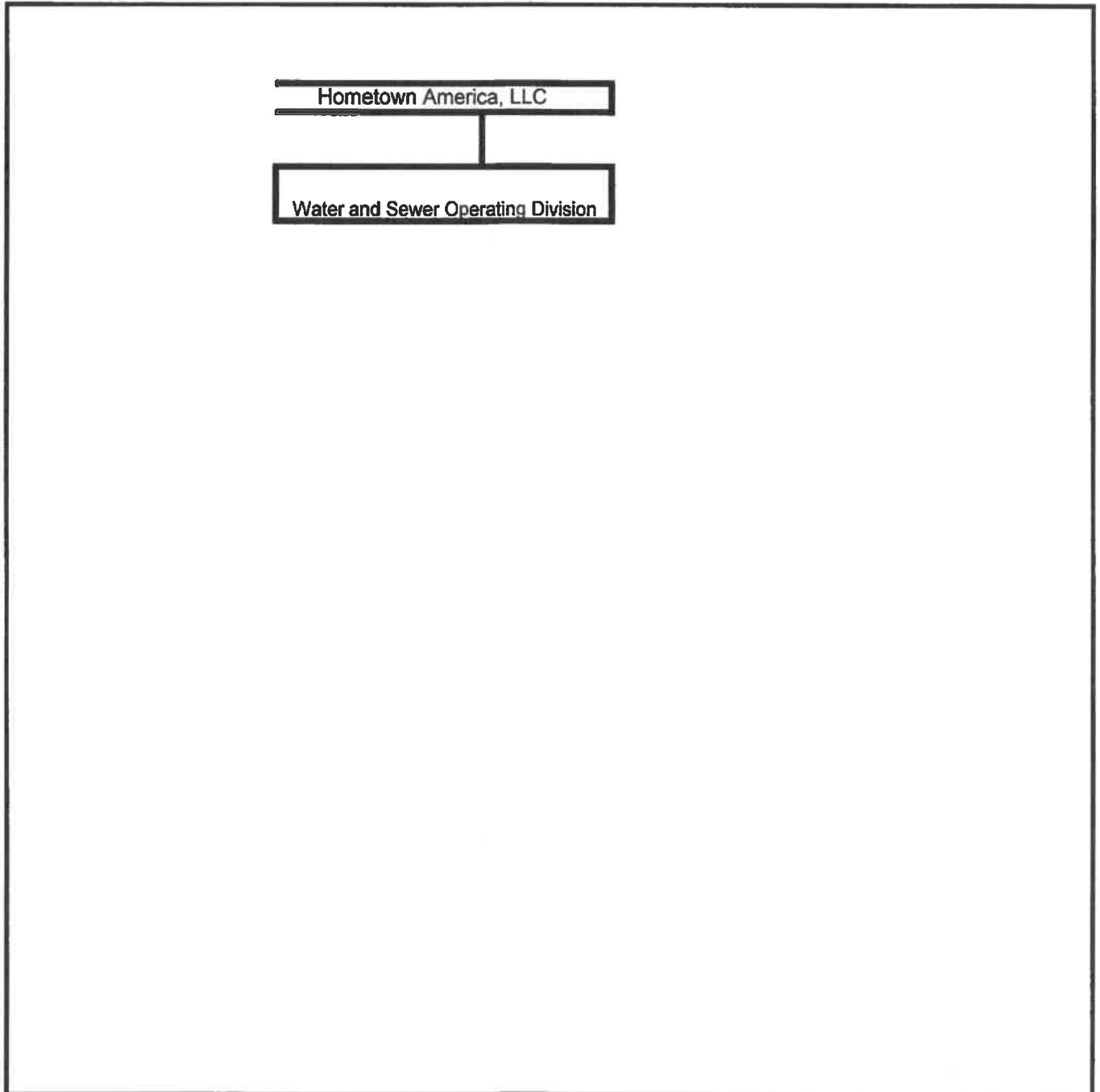
