

SECTION 2 – REGULATIONS

2.14 Use of Service

Effective February 1, 2009, residential and small business customers currently subscribed to Company local service in areas in which local exchange service is provided by any subsidiary or affiliate of Verizon not subject to this tariff will no longer be able to move, add to, or change the service to which they are subscribed, except that customers may switch to a different Company service for which they are eligible if they wish, and customers may cancel local features on their service if they wish.
