Section 4 - SERVICE DESCRIPTION NETWORK SERVICES (Cont'd)

4.19 Prime on Integrated Network Connection Service (Prime on INCS)

4.19.1 <u>General</u>

Prime On INCS provides one of the following services: PrimeXpress, PrimePlex, PrimePath Lines or Prime Digital Trunks over an INCS access arrangement. Each individual Customer location must be in an area where AT&T has the necessary facilities.

4.19.2 Provisioning

The INCS access arrangement will connect to the Customer's premises via a T1 line. Customer must provide compatible customer premise equipment, (CPE), and interfaces to support the Local voice line and trunk applications.

4.19.3 Types of Service

Types of service delivery of INCS with the $\ensuremath{\mathsf{Prime}}$ services are as follows:

<u>PrimeXpress</u> - delivers as 24 (twenty four) voice grade digital channels.

- <u>PrimePlex</u> delivers current functionality, excluding the delivery of Switched Digital Service with 64KBPS T End-to-End through the network.
- <u>Prime Digital Trunks</u> delivered as 8-23 voice grade digital C channels. If 24 digital channels are required, a DS-1 Digital facility must be used.
- <u>PrimePath Lines</u> delivers switched local exchange service for Customers with 8-24 analog DSO PrimePath Line needs.

Section 4 - SERVICE DESCRIPTION NETWORK SERVICES (Cont'd)

4.19 Prime on Integrated Network Connection Service (Prime on INCS)

4.19.4 Features

All standard requirements, capabilities and feature functionality that are available for use with PrimePlex, and PrimeXpress Services, PrimePath Lines and Prime Digital Trunks are available T for use with Prime On INCS at the rates and charges specified in this tariff.

4.19.5 Application of Rates

Prime On INCS rates consist of a non-recurring and monthly recurring charge. All voice services delivered over INCS are billed separately.

Prime On INCS is available on a 1, 2 or 3-year term commitment as described in the Rates section.
