 - .9 Prepaid Calling Card Services
 - .1 Sprint Prepaid Calling Card Service is an add-on to the interstate offering. Individual cards are specified in Section 6.6.9 of this tariff. Prepaid Calling Card Service allows a customer to pay a fixed dollar amount in advance for long distance calling over Sprint's network. The customer will use the toll free number on the card to access Sprint's network. The customer can place intrastate, interstate and inter-national direct dial calls. A flat per-minute cost of a call will be deducted on a real-time basis as the card is used until the full amount of the card is exhausted. Fractional minutes are rounded up to the next full minute. The customer will be notified in advance of the exhaustion of the card. The rates paid by the customer until the card is exhausted will be those in effect at the time the card is purchased. The same per minute rates apply when the card is refreshed unless otherwise stated in this tariff. The expiration date is printed on the card. For cards with specific payphone surcharges listed with the card rates, no additional payphone surcharge rates will apply. Calls placed from a rotary phone will default to a Sprint Operator for call dialing only. Per-call connection fees are listed with each individual prepaid card as applicable.

The following types of calls may not be completed with the aforementioned Prepaid Calling Cards:

- * Calls to 700, 800, and 900 numbers.
- * Calls to Directory Assistance.
- * Operator assistance calls (except for calls placed from a rotary phone as described above).
- Conference calls.
- * Calls requiring time and or charges.

The cards will be offered to customers on a first come first served basis.

Sprint will offer prepaid calling card service to be purchased through the function keys of ATM's (Automated Teller Machines). ATM screens from which this service is available will be programmed to offer \$10, \$20, and \$50 long distance vouchers. Customers will be able to request the vouchers just as they request cash or account information. The ATM will debit the customer's account for the purchase amount. Once a denomination is selected, the ATM will print out two receipts: the first will include the transaction information and the second will include the 800 access number. the customer's PIN and the expiration date. The customer will use the 800 number for access from touch tone phones. A flat per-minute rate will be charged. The per-minute cost of a call will be deducted on a real-time basis. The customer will be notified in advance of the exhaustion of the prepaid service. The following types of calls may not be completed with the ATM Prepaid Calling Card Service: calls to 700, 800, and 900 numbers, calls to Directory Assistance, Operator Assisted calls, calls requiring time and/or charges. This service is an add-on to Sprint's interstate ATM Prepaid Calling Card Service contained in Sprint's interstate Consumer Rates and Conditions at http://www.sprint.com/ ratesandconditions.
