The purpose of this filing is to Increase Monthly Recurring Charges for Clearline 1.5, Clearline Digital Date Service, Clearline Voiceband, Clearline Fractional 1.5 and Clearline 45 Services.

Sprint's intrastate Private Line Access Facility, Central Office Connection and Access Coordination Fee rate elements are being brought into parity with its interstate rates; therefore, Sprint will reference its Interstate rate Schedules 7 and 8.
