4 TERMS AND CONDITIONS (Continued)

.6 Ownership of Facilities

Title to all facilities provided by Carrier in accordance with these regulations remains with the Carrier.

.7 Application of Service

The Carrier may require a subscriber to sign an application form furnished by the Carrier and to establish his credit as provided in these Regulations, as a condition precedent to the initial establishment of such service. Carrier's acceptance of an order for service to be provided an applicant whose credit has not been duly established may be subject to the provisions described in the Deposit Section of this Tariff.

The Carrier may also require a signed authorization from the subscriber for additions to or changes in existing service for such subscriber.

An application for service canceled by the subscriber or the Carrier prior to the establishment of the service applied for is subject to the provisions of this Tariff.

.1 Stand Alone Travel Card

Carrier reserves the right to require the applicant to undergo a credit review. If the carrier determines that the applicant does not pass its credit review process, carrier reserves the right to refuse service.

.8 IXC Resellers

Customers reselling or rebilling services must have a Certificate of Public Convenience and Necessity as an interexchange carrier from the Florida Public Service Commission. This applies to all services offered to Sprint customers as described in this tariff.

.9 Hearing/Speech Impaired Discounts

Intrastate toll message rates for TDD users shall be evening rates for daytime calls and night rates for evening and night calls.

.10 Telecommunications Relay Service

Intrastate toll calls received from the relay service shall receive the following discounts.

- .1 Sprint Relay users will not be charged for the initial three minutes of any telecommunications relay service established intrastate toll call.
- .2 All additional minutes after the first three initial minutes will be discounted 60 percent off the Sprint Service per-minute usage rates.
- .3 These discounts commence on June 1, 2005 and will continue for a period of three (3) years, unless earlier terminated or modified in accordance with this Tariff. These discounts may be extended for four (4) additional years.
