### .5 SERVICE AND RATE DESCRIPTION (Continued)

#### .2 WATS

WATS is an intercity service available for use by subscribers 24 hours a day, which is priced in such a manner as to make it attractive to large volume users. No special dial-up procedure is necessary to gain access to Sprint's network. Subscribers may originate WATS from the originating locations as described in Section 3 and may terminate calls in all locations outside an originating EAEA within the State of Florida.

Per-minute rates for WATS are set forth in Section 6.2 of this tariff. Sprint provides the service of connecting WATS subscribers to the Local Exchange Company-Directory Assistance (LEC-DA) for a fee as described in Section 6.6 of this tariff, for interLATA information requests. Stand-Alone Travel Service is available to WATS subscribers. Operator Service is also available to WATS subscribers.

WATS for intrastate use is sold as an add-on service to Carrier's interstate service. Accordingly, nonrecurring and monthly recurring charges are found in Sprint's interstate tariff, F.C.C. No. 2. Discounts may apply to intrastate usage as set forth in Section 6.2.

Several options are available under WATS: Sprint Advanced WATS\*, Dial "1" (Z) WATS\*, Ultra WATS\*, Banded WATS\*, Sprint Advanced WATS Plus\*, and Dial "1" (Z) WATS Advantage\*. (Z)(D)



# .4 Sprint Advanced WATS Plus\*

Sprint Advanced WATS Plus calls are originated via WATS Access Lines (WALs) and are terminated via normal shared use facilities. Charges for Sprint Advanced WATS Plus are based on duration of the call, rate period (Day, Evening, Night/Weekend) when the call is originated, and total monthly usage within each service group for each rate period.

# 5. Dial "1" WATS Advantage\*

Dial "1" WATS Advantage calls are originated in Equal Access Areas via Feature Group D (FGD) connections and are terminated via normal shared use facilities. Service is available on a single or multi-location basis. Subscribers receive a FŌNCARD Advantage calling card to place calls when away from their primary service location. Charges for Dial "1" WATS Advantage are based on duration of the call and rate period when the call originated. Dial "1" WATS Advantage and FŌNCARD Advantage usage is aggregated from all locations for purposes of applying volume discounts.

# .4 Private Line Service @

(C)

Private Line Service provides dedicated circuits which connect distant locations on the Carrier's network. These are non-switched point-to-point services over fully dedicated lines at fixed monthly rate. These circuits are dedicated to a subscriber for his exclusive use 24 hours per day. Facilities are offered in numerous configurations to meet the particular transmission needs of the subscriber. Private Line Service is available between points of presence (POPs). One (1) service is currently available under Private Line Service: Clearline Services, which include, CLEARLINE 1.5 Service, Clearline Digital Data Services, Clearline Voiceband, Clearline Fractional 1.5 and Clearline 45 Service.

### .1 Clearline Services

Clearline 1.5 Service is offered by Sprint between POPs on its fiber-optic network. The service is offered in the form of discrete intercity communication facilities which are dedicated to the use of a specific subscriber and provides simultaneous transmission of isochronous digital signals at a speed of 1.544 mbps. Access from subscriber premises to Carrier's network is via a T-1 access line which provides a direct digital transmission connection at 1.544 mbps, or the equivalent of twenty-four (24) voice channels. Charges for Clearline 1.5 Service is based on distance between the Carrier's POPs and access arrangements.




