  - .16 Sprint Global Access Calling Card Service

This calling card service applies to customers who have their local telephone service through Embarq, Inc. (formerly known as Sprint Local Telephone) and have a Sprint Global Access Calling Card. Sprint Communications Company L.P. will be the long distance intrastate provider to Sprint Global Access Calling Card customers. Calls will be placed over Sprint's network by dialing 1-800-210-2273. All calls are billed in 60 second increments. The following types of calls may not be completed with the Sprint Global Access Calling Card Service:

- \* Calls to 700, 900 and toll free number
- \* Calls requiring time and/or charges

Per Call Charge	\$.00

.2 Calls Placed To a Customer's Primary Billing Telephone Number\*

Per-Minute Rate	\$.10
Per Call Charge	\$.75

.3 All Other Calls Placed By a Sprint Global Access Calling Card Customer

Per-Minute Rate	\$.45
Per Call Charge	\$.75
