The SDS Volume Plan offers specialized usage rates for new or existing Customers who sign up for a 1, 2, or 3 year term plan and commit to incurring at least \$50 - \$16,500 per month (\$600 - \$198,000 annually) in gross annual revenue.

11.3.4 SDS Volume Plan Discount

Effective August 3, 2006, AT&T will offer a 20% monthly discount on the SDS Volume Plan usage rates as specified in the Rate Schedule.

For months that the customer does not meet the monthly commitment, the customer will be billed the Volume Plan usage charges as specified in the Rate Schedule for that month. However, if the customer meets their annual commitment, a credit will be applied for the month(s) the customer usage was not discounted. This credit is equal to the difference between the undiscounted and discounted usage for that month. Additionally, this credit will expire within six (6) months of posting to that same account that generated the usage.

If the customer meets their annual commitment any time during the year, the customer will receive the discount for the remainder of the plan year as applicable.
