The purpose of this filing is to increase rates for certain residential and business non-basic and optional services.

This filing impacts the following non-basic categories: Category 1 - Business Non-Basic, Category 2 - Residential Non-Basic and Category 4 - Other Optional Services.

Based on the rate increases made in the above non-basic categories effective November 1, 2005, July 1, 2006 and August 1, 2006, the total cumulative percentage increases by category are as follows:

Category 1 – 1.5%
Category 2 – 5.0%
Category 4 – 5.5%

A redacted copy of the revenue summary of the August 1, 2006 rate increases is included with this filing.
