Attached are revised tariff pages filed to become part of the Verizon Florida LLC General Services Tariff.

Section A13 Miscellaneous Service Arrangements 7th Revised Page 11.4.5

The purpose of this filing is to increase the service rate for Unlimited ECS and Toll Usage for Business Feature Packages One, Two and Three.

Verizon prepared a tariff filing to increase ECS Feature Package rates by \$1.00 effective on December 19, 2009. Customers were notified of the pending increase through bill messages that ran during the October and November billing cycles. The new rates were implemented in Verizon's systems and began billing on December 19 as scheduled. Verizon posted the new tariff page on its publicly available tariff website showing the new rates and at the same time archived the old tariff sheet containing the previous rates.

As part of the normal tariff filing process, Verizon prepared the standard tariff package for filing with the PSC showing an issue date of December 18, 2009 and an effective date of December 19, 2009. However, due to an administrative oversight, the tariff package was not filed as scheduled with the PSC. Although customers were notified in advance of the rate increase and the new rates were published on Verizon's publically available tariff website, this resulted in the PSC tariff pages not being updated. This filing corrects the record to reflect the proper tariff sheet.
